Re: Public Records Act Request – 108th Annual Awards Dinner on March 12, 2016

Dear Mr. Houlemard:

This is a California Public Records Act request on behalf of Keep Fort Ord Wild to inspect, and possibly copy the records as follows.

1. All records, including communications, referring to, mentioning, or discussing the dinner or the event. The term "dinner" or "event" refers to the 108th Annual Awards Dinner by the Monterey Peninsula Chamber of Commerce on March 12, 2016.
2. All records showing where the \$1,500 came from. If the \$1,500 came from a fund, we seek the records that identify the source of the revenue for the fund.
3. All records, including records of communications, of any person who was invited to and/or attend the event at FORA's table, FORA's expense, or on behalf of FORA. This category includes persons who reimbursed FORA.
4. All records, including records of communications, that show the identity of all persons who drafted and approved the staff report for item 8b of the recent FORA executive committee meeting at which \$1500 was approved.
5. The records sufficient to show (a) the identities of the executive committee members present at the recent meeting and (b) their vote on item 8b.

The request includes all communications, including notes of meetings, notes of conversations, records of transmittals, emails, email attachments and other electronic records in their native format, including those scanned into the electronic project files, residing on staff computers and on the shared drive(s), and in archived form. Our clients request the records in the form held by the agency. (See Gov. Code, § 6253.9, subd. (a).)

We ask to receive copies of electronic records in native electronic format. (Gov. Code, § 6253.9, subd. (a).) Please place the records on a flash drive or CD.

I draw FORA's attention to Government Code section 6253.1, which requires a public agency to assist the public in making a focused and effective request. If FORA determines that any of the information is exempt from disclosure, I ask that FORA exercise its discretion to disclose some or all of the records notwithstanding the exemption. With respect to records containing both exempt and non-exempt content, I ask that FORA redact the exempt content and disclose the rest.

Should FORA deny part or all of this request, FORA is required to provide a written response describing the legal authority on which FORA relies.
