Dear Marina Airport Master Plan PAC Member,

The purpose of this email is to inform you that the City of Marina has initiated an Initial Study per the *California Environmental Quality Act* (CEQA) to evaluate the potential environmental impacts related to adoption of the draft Marina Municipal Airport Master Plan. This is the next step in obtaining final Master Plan approval by the City Council.

The Initial Study will be looking at the Master Plan at a *programmatic* level, i.e., it will not address specific projects within the Master Plan at a detailed *project* level at this time. As specific projects recommended within the Master Plan require discretionary approvals, the City will conduct both the state (per CEQA) and the federal (per the *National Environmental Policy Act*, i.e., NEPA) environmental review processes, as necessary, at that time.

Once the Initial Study is completed, you will have a chance to review it and provide comment, as will any interested member of the public.
