## Re: Informal Bid for Fire Prevention and Weed Abatement at the Surplus II site in Seaside California

Purpose: FORA is maintaining the Surplus II site while preparing for future Surplus II Building Removal.

**Scope:** FORA is recieving bids through it's public bid process for the clearing of vegetation at the Surplus II site located between Gigling Road and Col. Durham (See Drawings in **Attachment A**). The Scope includes the cutting, trimming, mowing, gathering and disposal of vegetation onsite, over three phases (see Drawings).

- Chip bushes, shrubs, and trees less than 6" diameter at 5' above ground surface.
- Limb-up trees over 6" in diameter at 5' above ground surface to nine feet (9') above ground surface.
- Cut, mow, trim, grasses and weeds to 6 inches, ± 4inches above ground surface
- Provide FORA with written or photographic Daily Update Reports including a list of employees that worked on site during the week and the wage rates they were paid.
- Replace pink tag/tree number after limbing, if removed, or re-number tree with waterbased paint.

## **Exclusions:**

• Iceplant, trash, hazardsous materials or waste.

## Milestone Schedule:

Provide a payment milestone schedule for each phase of work (see Drawings). Each milestone must have a clearly defined deliverable by which FORA can measure/validate completeness. (i.e. 3 of 4 trees will be limbed, and all vegetation west of building XXX will be cut...)

**Prevailing Wage:** For Respondent's bid to be considered, respondent must provide proof of DLIR Registration in the proposal. A list of personel working on this project with the wage rates they will be paid will be submitted to FORA before the Start of Work. Failure to provide this list of personel and keep it up to date during the work will be grounds for terminating the contract. FORA reserves the right to contact personel working on site and interview them to confirm they are receiving the wage rates listed.

This project is a public works project, and is subject to prevailing wage rate laws (see Contract General Conditions). Pursuant to Labor Code sections 1770 et seq., FORA has obtained from the Department of Industrial Relations determinations of the prevailing wage rates and the prevailing wage rates for holiday and overtime work in the locality in which the Work is to be performed.
