5. BUSINESS ITEMS

a. Review latest Administrative DRAFT RUDG revisions

Chair Houlemard introduced RUDG consultant, Jason King with Dover, Kohl & Partners (DKP). Project manager Josh Metz commented Task Force members continue its review of the guidelines. Chair Houlemard reminded Task Force objective is to present RUDG "working draft" at future Board meeting.

Mr. King noted that comments from the August 27, 2015 Task Force meeting were included in the latest draft RUDG document. Mr. King delivered a presentation noting that the latest draft RUDG was user

friendly. More graphics and local pictorial examples have been incorporated. Suggestions regarding inclusion of signage guidelines incorporated TAMC Wayfinding design concepts.

Layne Long commented that perhaps architectural landscape designs be included in RUDG. Additional workshops may be needed to explore this possibility.

There was general discussion on the RUDG Introduction section contents. Lisa Brinton emphasized need to clarify when RUDG is applicable on projects. Members suggested the RUDG include more vivid colors to highlight important areas. Anya Spear proposed that CSUMB be identified as a center.

There was also general discussion on distinguishing between "centers" and "gateways." Victoria Beach commented that gateways contain specific dimensions and types of landscaping to FORA entrances. John Dunn recommended that specific names be included on gateway signage and any maps produced by consultants.

Additional Task Force discussion was conducted on the trails portion in RUDG. Mr. Dunn expressed desire to represent connections on maps including bicycle / pedestrian connections in local jurisdictions. Mr. King commented that DKP would take this into consideration. Trails would be revisited at the next Task Forces scheduled for Thursday, October 12, 2015 at 10:00 a.m.
